

What is the challenge?

For many young people, especially for young people with special education needs or difficult socio-economic background the interface between **lower secondary education and the entrance into the labour market** is a sensible stage of development. The high risk to drop out of education or training without having a job often has serious consequences for the whole life of young people. Low levels of education do also have high economic and social consequences for society.

What is the contribution to a solution?



The partnership of the project consists of 6 organisations from Austria, Germany, Italy, Malta, Poland and Spain.

In Austria the Bundessozialamt has implemented the "Youth Coaching" Model that offers support for young people. It is based on counselling, networking, case management and career planning. One of the biggest challenges in European countries is how to reach young people and how to motivate youth at risk for education and training programs.

MY WAY will combine **Youth Coaching** with **Peer Group Workshops** as an instrument to reach and motivate young people. The Model will be optimised by the influence of European good practices within the network and transferred to European countries. MY WAY could be a participative intervention **to reduce the drop-out rate of young people in education**.

Who is doing what?





How can it work?

Young people from all partner countries will be experts in their own matter. After an international **Train the Trainer Workshop** the young people will organise **Peer Group Workshops** in their home countries in order to reach more young people at risk.

This Compilation will include most of all **exchange** and **analyses** of existing empowering support and interventions for youth at risk that lead to innovative practises and recommendations in the practical working field with educational programs for youth at risk and learners with special needs. The exchanged, analysed and upgraded Youth Coaching concept can be adapted for use in different European states.

What will be available?

The **main results** of the project will include a Web Site and the MY WAY Compilation containing:

- The state of the art of services and interventions concerning youth at risk in Austria, Germany, Italy, Malta, Poland and Spain and in other European countries.
- Good practice examples concerning empowering interventions for the integration of youth at risk into training and educational programs.
- The overview of the Austrian Youth Coaching concept and recommendations for improvement.
- Curricula for the Train the Trainer and Peer Group Workshops.
- The guideline for a successful transfer and implementation in different European countries.
