Patent filings at the EPO reach all-time high

Patent filings at the EPO grew by 2.8% last year, hit another all-time high, showing that EU continues to be a key market for innovation. In 2013 the EPO received 266 000 patent filings, compared to 258 000 in 2012. The EPO granted 66 700 EU patents, which was 1.6% more than in 2012 (65 600), the highest number ever. "Demand for patent protection in Europe is up for the fourth consecutive year," said EPO President Benoît Battistelli. "This is proof that companies from around the world continue to see Europe more and more as a premier hub for innovation. The strong position of EU companies in patent-intensive technologies also underlines the central role these industry sectors play in generating employment and growth in the EU economy."

The Science-to-Business Marketing Research Centre, apprimo and UIIN, with the support of the European Commission (DGEAC), are proud to present 14 country-level reports on University-Business Cooperation. The 6,280 European academics and HEI representatives who responded to our survey made it the largest study into cooperation between HEIs and business yet completed in Europe. After presenting the general European results, national reports have been created to provide an overview and specific insights of University-Business Cooperation in 14 countries.

Innovation, Competitiveness and Entrepreneurship

Regional & EU Innovation Scoreboards 2014

All the EU regional innovation leaders (27 regions) are located in only eight EU Member States: Denmark, Germany, Finland, France, Ireland, Netherlands, Sweden, UK, as result innovation excellence is concentrated in relatively few areas in EU. At the EU regional level, most of the regions improved their innovation performance but at the same time innovation performance worsened for 35 regions scattered across 15 countries.

Europe's regions have been classified into Regional Innovation leaders (34 regions), Regional Innovation followers (57 regions), Regional Moderate innovators (68 regions) and Regional Modest innovators (31 regions).

See also the Innovation Union Scoreboard'14 which tell us that if the EU becomes more innovative but the differences between Member States are still high & diminish only slowly. As a result, the EU has closed half of the innovation gap towards the US. Most progress has been made in the openness and attractiveness of the EU research system as well as business innovation collaboration and the commercialisation of knowledge as measured by licence and patent revenues from abroad. However, the growth of public R&D expenditures over the last years was offset by a continuous decline in venture capital investments and non-R&D innovation investments in companies.
