European Commission - Communication on Research and Innovation and State of the Innovation Union Report

The EC published a Communication on "Research and Innovation as sources of renewed growth". It is underpinned by the 2014 "State of the Innovation Union Report" that details the steps taken since 2010 to implement the Innovation Union flagship initiative of the Europe 2020 growth strategy.

The majority of the Member States need to increase their expenditures for research & innovation to make further progress toward the Europe 2020 R&D investment target of 3 % of GDP. The EC suggests reforms of national R&I policies and identifies three axes to enhance new growth opportunities, which are relevant to all Member States:

- Improving the quality of strategy development and the policy making process
- Improving the quality of programmes, focusing of resources and funding mechanisms
- Optimising the quality of public institutions performing research and innovation

The EC will review the currently available tools to assess the quality, effectiveness of R&I reforms, launch discussions with Member States on the implementation of the R&I priority.

IMD World Competitiveness Yearbook

The IMD World Competitiveness Yearbook is reputed as being the worldwide reference point on the competitiveness of nations, ranking, analyzing how an economy manages the totality of its resources, competencies to increase the prosperity of its population. Smart specialisation is not about central planning

The EC is promoting a 'smart specialisation' strategy for innovation where regions focus efforts and spending on their strengths rather than spread investments too thinly. But the hardest part is what to drop. The EU's Horizon 2020 foresees a big increase in funding for innovation. Is funding less of an issue now for entrepreneurs?

Horizon 2020 is growing substantially compared to the previous programme (FP7), from €50 to 80 billion, it only represents 8% of the total EU budget and 8% of what member states are spending on science and innovation on a yearly basis. So we have to put this into perspective.

Looking at national governments, the fact that Spain has cut €600 million from its science budget is not good in the long run.

The decrease of the green energy costs for industry mustn't press the consumers

Government of Romania adopted an exemption of 40-85% for large industry players from the payment of green certificates. But the redistribution is not compulsory. *According to the Guidelines adopted by the EC regarding the public support for the environment protection & energy projects, the redistribution of the green certificates quota has to be applied only to the countries that didn't achieve the green energy targets*, say the members of the Big Industrial Energy Consumers.
