### Has Crowdsourcing Become A Mainstream Innovation Tool?

Last year's [study](#) by Henry Chesbrough and Sabine Brunswicker showed that large companies in Europe and the U.S. were increasingly using open innovation in their business practices. When asked which specific open innovation tools they employed the most, the respondents chose customer co-creation, informal networking, university grants. At the same time, crowdsourcing and working with open innovation services providers (OISP) were rated lowest in importance.

According to the study, much-hyped crowdsourcing has not become an open innovation tool of choice for large EU & U.S. companies. Why? because using crowdsourcing requires special expertise? or, it's useful only in certain industries?

### **Europe needs a building renovations directive**

[SPECIAL REPORT](#) / Europe's struggling bid to rein back energy wastage in the building sector could be boosted by a renovations directive implemented under a new Directorate-General for Resource Efficiency, says the sustainable energy think tank E3G. Cutting CO2 emissions in the building sector, which currently accounts for 43% of the EU's total, will be essential for the bloc to meet its goal of decarbonising its economy at least 80% by 2050.

But only 16 of the EU's 28 countries have written the flagship Energy Performance of Buildings Directive (EPBD) into law, and proposals have been beset by loopholes and implementation issues. The EPBD, which is due for review next year, requires [energy performance certificates](#) to be issued to buildings over 250 metres squared by 2015 and sets a binding target for all new European buildings to be nearly-zero emitters by 2021.
