### SME Instrument: 6 lessons learnt from the first evaluation (that are also tips for the applicants)


As the SME Instrument is a brand new funding opportunity, we did not know what to expect from the first round of applications. The Instrument is very selective and only the best of the best can succeed. We received some excellent proposals − 155 champions of innovation will soon get €50,000 to finance a feasibility study.

But many proposals that were not good enough to compete in the innovation champions' league.

Here are 6 lessons we learnt from this very first evaluation exercise that we think can be useful for the future applicants.
